It was noted that the shoulders of the road were washing out in places because of the large amount of rain we've been receiving. Discussion was held about whether to fix them now or do them in the spring along with other gravel issues. It was also noted that Mapleview Road North may also be in need of some shoulder work. These will be checked into.

RE: Mapleview Road – Discussion was held concerning repair on Mapleview Road South. It was noted that 300th Street at the end of Mapleview Road retains water. Discussion was held concerning the situation. It will be checked into. No further decisions were made concerning the Mapleview Road South repair project.

RE: Sign Reflectivity Survey – Mike Nelson from MN Engineering and Construction Services reported that they are almost finished with the sign inventory.

RE: Dog Complaint – Judy Bruemmer reported that the Brady Brix dog has been seen wandering around the town. A letter will be sent to remind them of the dog ordinance.

RE: Newsletter – The fall newsletter was reviewed and discussed. The final copy of the newsletter will be reviewed at the October meeting.

RE: Chain of Lakes Fire and Rescue District – It was reported that meetings are still on-going. No agreement has been reached with the City of Richmond. Discussion was held.
