

Official Minutes 4.5.11

RE: 223rd Repair – Fred Holthaus reported on the repair spot on 223rd Ave. Discussion was held. Fred presented concerns about the road by Schueller. These matters will be looked into during Road Tour.

RE: Blading Quotes – Two quotes were received for blading township roads and were opened at 9:00 pm. They were: SunnyBrook Enterprises \$36.00/mile and Lange Trenching \$38.50/mile. Discussion was held. Neil Franz made a motion to hire SunnyBrook Enterprises to blade the township roads, Dan Stommes seconded. All in favor, motion carried.

RE: Gravel Quotes – Supervisors were reminded that gravel quotes will be opened at the May monthly meeting.

RE: Zoning – Bill Otto gave a short report on zoning matters. The notification regarding changes in the county zoning ordinance was discussed and will be reviewed.

RE: Chain of Lakes Fire and Rescue District – It was noted that the next meeting of the Fire District will be held at Collegeville Town Hall to view equipment the Fire District received. The meeting will be posted. The new meeting schedule for the Fire District will also be posted.
